- **Apartment & Rental Complexes (Long Term):** \$250.
- **Assisted Living/Nursing Facilities:** Base fee of \$150, plus \$2.50 per bed.
- **Business:** Owner and up to 10 employees \$185. Over 10 employees, plus \$2.50 for each additional full-time employee. (Two part-time employees equal one full-time employee). Add \$75 for each additional location.
- **Campground:** \$150.
- **Credit Union:** \$250
- **Educational Institution:** Less than 5,000 enrollment, \$250. Over 5,000 enrollment, \$500.
- **Financial Institution:** \$500. Additional locations: \$125.

- **Food & Beverage:** (Restaurant/Brewery/Wine, cheese, chocolate Shops/Cocktail lounges, etc.) \$175 plus \$1 per seat for each seat over 100
- **Food/Beverage Service fee:** \$25 additional fee for members whose primary business is lodging or other, but serve food in a secondary capacity.

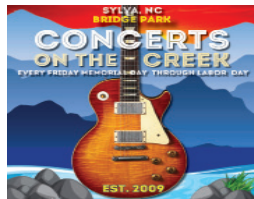
